Extension of vocational training contracts: co-determination right of trainees

The Federal Labour Court has provided further adjudication on the issue of the possible extension of training contracts in the form of a verdict issued on 14 January 2009. This states that a vocational education and training contract is not automatically extended to cover successful completion of the final examination if such an examination does not take place until after the term of the agreed period of training. The present paper investigates fundamental verdicts relating to a range of case scenarios handed down by the Federal Labour Court over the past ten years. This then serves as the basis for an explanation of unresolved issues with a view to achieving the securest possible legal application in practice.
